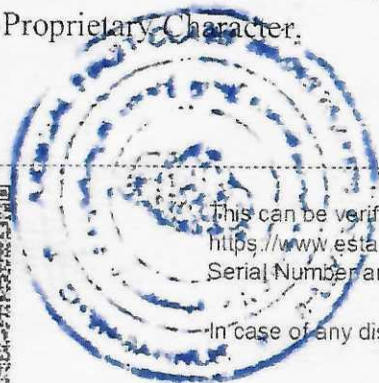

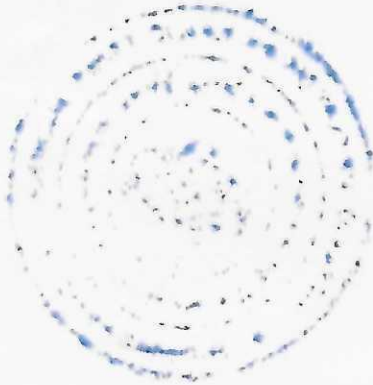
13. That the School will not coerce any student / parent to buy books / stationary / uniform from any particular shop.
